## Application for Admission 2022

Rivonia Primary School is a co-educational, English-medium, Section 21, Fee-Paying school.

### **DOCUMENTATION – PLEASE SUPPLY CERTIFIED COPIES OF ALL DOCUMENTS.**

**The following documentation must be submitted with the completed application form:**

- a) Child's latest certified copy of school report, where applicable.
- b) Child's official **certified Unabridged** birth certificate stating details of the father, mother and learner / certified copy obtained from the regional office of the Department of Home Affairs.
- c) Child's official **certified** immunisation card, confirming all immunisation is up to date.
- d) Proof of residential address, in the parent's name. **ONLY ORIGINAL** statements of rates, water and lights (FICA compliant) will be accepted. **Offers to purchase and affidavits are not regarded as bona fida proof of residence.**
- e) In the case where parents are renting property the following documentation needs to be submitted as proof of residential address (**ALL** of the following documents)
  - a. **Copy** of the Rental Agreement (valid for at least a year)
  - b. Landlord's Contact details (if not on Lease)
  - c. **ONLY ORIGINAL** Current Rental Statement (**Utilities**)
- f) Proof of employment address for both parents and/or guardians and/or foster parents if **Permanently Employed**.
- g) Proof of employment address for both parents and/or guardians and/or foster parents if **Self Employed**.
- h) Company Relocation / Transfer letter (if applicable).
- i) Certified copies of **both** biological parents' or/and guardian's or/and foster parents' identity documents.
- j) In the case of guardians/foster parents a letter from a social worker or qualified legal representative confirming that the guardian/foster parent has been appointed by the court.

### **Parents/Guardians of other nationalities must submit the following additional documents**

- a) Certified copy of work permit/visa in respect of the parents and/or guardians
- b) Certified copy of Study Visa in respect of the learner
- c) Certified copy of temporary or permanent residence permit from the South African Department of Home Affairs
